**RLD/RLD-2** specification defines an engine oil meeting at least *ACEA-E7-04* classification+VDS-3.

**RXD** specification defines an engine oil meeting at least *ACEA E4 +E7* classification +VDS-3.

**RLD-3** specification defines an engine oil meeting at least *ACEA-E9-08* classification +VDS-4.

**RGD** specification defines a specific lubricant for gas engines that meet the following requirements:

ACEA -E6 level+ VDS3 (excluding engine tests)  
TBN = 6/8  
Sulphated ash  $\leq$  1%


